OPERATORS

ADDING A NEW OPERATOR - FOR POWERBOATS ONLY (Office Use Only)

- You must supply a copy of your Oregon State Marine Board Card or Certificate of Completion.
- Take & pass the LOC written exam on Oswego Lake Rules & Regulations.
- Take the LOC driving exam within 60 days of passing the LOC written exam.
- LOC Operator's license will be issued upon passing LOC driving exam.

REGISTRATION FOR LAKE USER - INSTRUCTIONS

Registration can be completed by mail or online at www.lakecorp.com

Review entire registration form for accuracy

- Make legible corrections as needed, crossing out old data and writing in the new / correct information.
- Provide missing information. (IE: phone numbers, email addresses, mailing address if different)
- Verify all watercraft information is correct and provide missing information. (IE: copy of OR State Boat Title, OSMB card, Boat Insurance Declaration Page)
- After review, mail the ENTIRE Registration form along with your payment.

Submit annual LOC easement member payment

- Payments can be made by cash, check, money order, Visa, MasterCard or Discover.
- Payments may be submitted online or by mail.

To schedule your ramp appointment the following items **MUST BE** received

- Annual LOC easement member fee paid in full
- Annual Easement member fee paid in full to easement
- Oregon State Boat Title provided (IE: purchased a new boat and had a temporary at time of launch)
- Current insurance declaration page submitted (if expired)
- Valid Operator—must have a LOC Standard license or current Learner's license and OSMB operator license
- Boat must have an intact wire clip.
- State of Oregon and LOC stickers must be current.
- Onboard safety equipment must meet the minimum requirements set forth by Oregon State Marine Law & Lake Oswego Rules & Regulations.

Power Boat Licensing

Insurance Requirements

- \$500,000 minimum liability (can be met by a combination of coverage including an umbrella policy). Must submit a copy of the current boat insurance declaration page showing policy holder name, policy number, policy period and amount of coverage.
- Insurance certificates can be faxed to 503 636-3226 or emailed to info@lakecorp.com.
- To ensure LOC receives updated coverage information upon policy renewal, LOC should be listed as Certificate Holder or Interested Party. Please give your agent our PO Box 203, Lake Oswego OR 97034 address.

Purchasing a new boat

- Ensure the boat falls within the LOC size & weight restrictions of the Rules and Regulations Handbook prior to purchasing

Section 5 - BOATS - GENERAL

5.a Length and Weight limits

Pontoon Boats shall not exceed **22 feet 6 inches** in length overall.

Other Boats shall not exceed **22 feet 0 inches** in hull length overall, including pickle-fork bows and excluding removable swim platforms.

No Boat shall exceed **3500 lbs** dry unit weight as described by the manufacturer's website or NADA guide.

- Provide a copy of your Oregon State Title or Temporary Title verifying ownership. The boat must be solely owned by homeowner with deeded Lake Or Easement rights.
- Provide a completed **Wake Enhancement Device Certification and Agreement** form confirming that your boat's wake enhancement device has been disabled. The form can be downloaded from www.lakecorp.com.
- Have the boat decontaminated by an official LOC approved vendor.

Obtaining a Powerboat Operator's License

- Complete and pass the Oregon State Marine Board Boater Education Course www.boatoregon.com.
- Provide a copy of the Certificate of Completion (valid for 30 days) or a copy of your OSMB Boater Education Card.
- Take and pass the LOC written exam covering the rules and regulations of Oswego Lake. No appointment is necessary. Tests are administered during regular marina hours. (At this time you are able to operate your boat)
- Within 60 days of passing the written exam, you must schedule and pass the LOC's driving exam administered by the LOC Lake Patrol. Please call 503 636-1422 to make an appointment for this exam.
- "Learner" operators who passed the written test but did not take the driving test within the 60 day period will have to repeat the written test and then complete the driving test.
