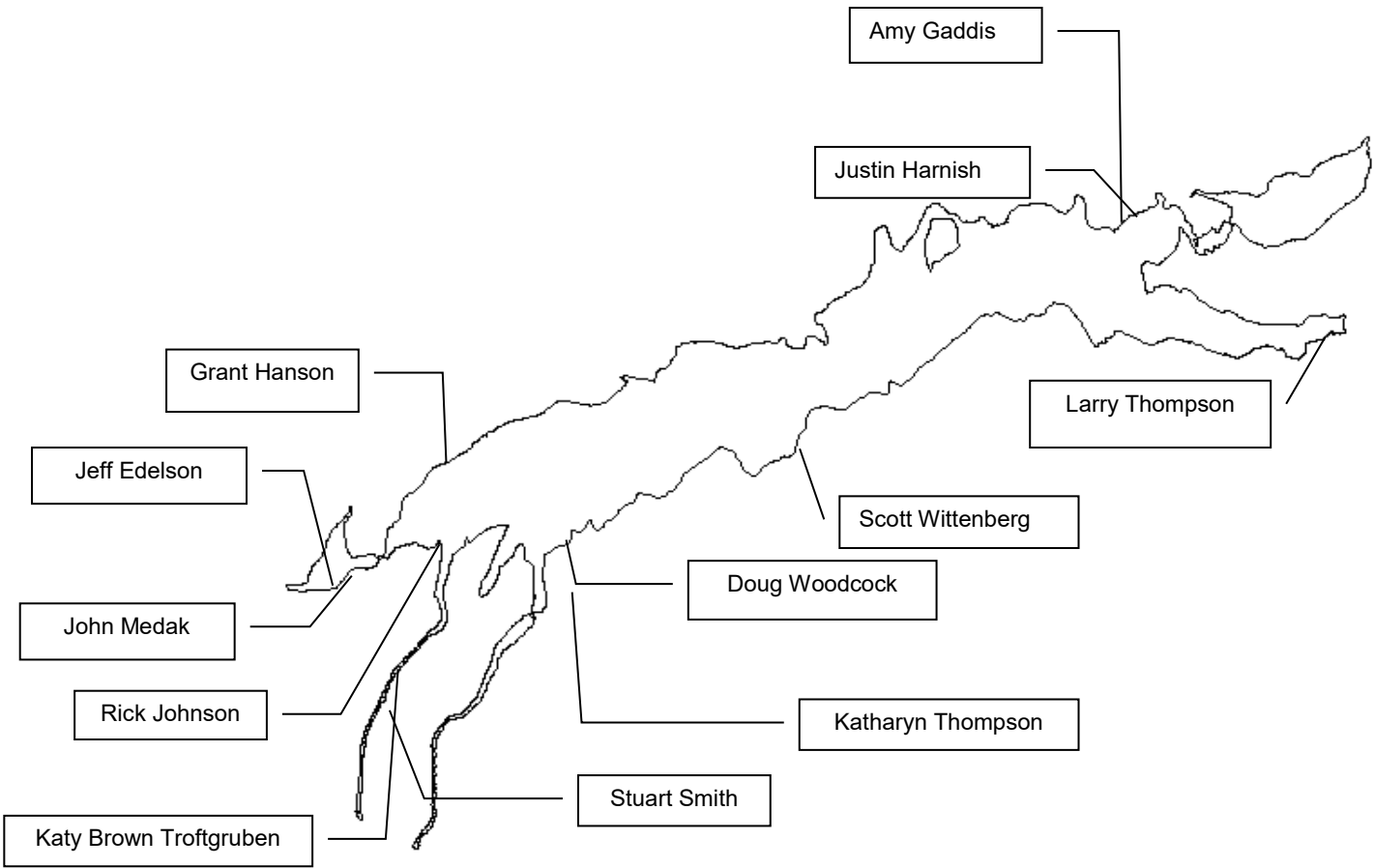
JOHN MEDAK
